Are the benefits truly outweighing the risks? Twenty years ago, ten vaccinations were on the schedule. Today? **36**. And it's not a careful **36**, it's an overly aggressive one-size-fits-all **36**. It's a sloppy **36** that hasn't been tested for cumulative safety. A risky **36** that contains some of the most harmful toxins on earth. An irresponsible **36** that starts for newborns only hours old. A profitable **36** that includes the Hepatitis B vaccine for a disease that's typically sexually transmitted, and the chicken pox vaccine for a disease that's not life-threatening with standard medical care. It's a careless **36** that has led to thousands of stories from parents who say their children regressed after receiving them. It's a growing **36**, with “fast tracked” vaccines like swine flu ready to be added. Hey, we hate disease just as much as the next guy, but first do no harm, right? Your job is to increase the *safe* use of vaccines.
